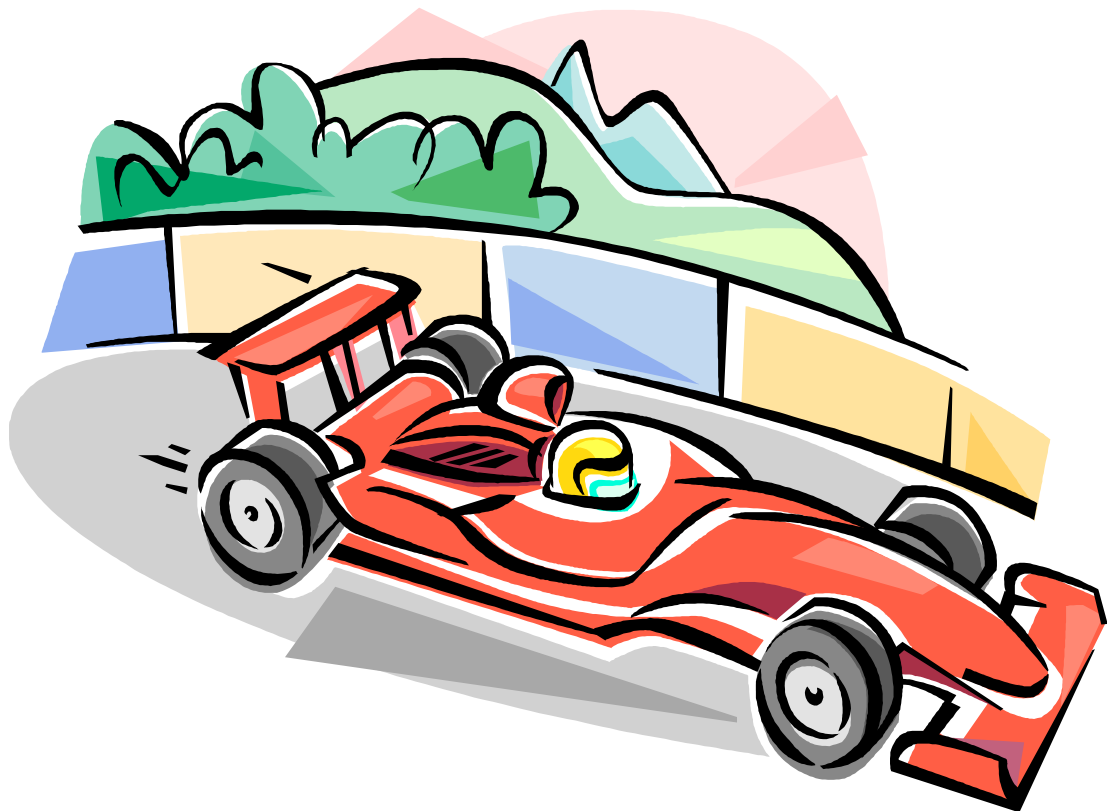

#### SUPPLEMENTARY REGULATIONS

**AUTHORITY** The event will be conducted under the International Sporting Code of the F.I.A., the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Limited (CAMS), Speed Events Standing Regulations, Victorian Hillclimb Championship Standing Regulations, these Supplementary Regulations, and any further regulations or instructions which may be issued, and shall be subject to CAMS PERMIT NUMBER 310/0602/01.

The event will be conducted under and in accordance with CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at [www.cams.com.au](http://www.cams.com.au)

**THE EVENT** The event will be a State Championship Hillclimb and **ROUND 1** of the **2010 VICTORIAN HILLCLIMB CHAMPIONSHIP** to be conducted at Bryant Park, Haunted Hills, Bill Schulz Drive, Yallourn on Saturday February 6, 2010. The event will be a **Twilight Hillclimb**, commencing at 1.00 p.m. and concluding at approximately 7.00 p.m.. The event is a round of the 2010 NGK Junior Pentathlon Series.

**ENTRIES** Entries will open **with the publication of these regulations**, and will close at close of business on **Tuesday, February 2, 2010**. Entry fee will be **\$88 (Junior entry fee for drivers under the age of 18 on the day of the event will be \$44)**. Entry fees include GST. Cheques and Money Orders should be made payable to the Gippsland Car Club Incorporated. Entry forms must be completed in full, accompanied by the entry fee, and be lodged with the Secretary of the Meeting.

The Promoters have arranged Public Risk Insurance to the requirements of Appendix I of the NCR. The Promoters reserve the right to stipulate the number of entries for the Meeting, and select entries in excess of such number at their absolute discretion. The maximum number of entries shall be 120, accepted in order of receipt. The Promoter reserves the right to refuse entry in accordance with NCR83.

**COMPETITION** Official runs will commence at 1.00 p.m. on Saturday, February 6, 2010 – the number of official runs will be notified at the Driver's Briefing.

**PERSONS ELIGIBLE** The event shall be open to members of clubs affiliated with CAMS who are holders of a CAMS Level 2S or higher Licence.

**SCRUTINY** Scrutiny will commence at 9.00 a.m. and conclude at 12.0 p.m. on Saturday, February 6, 2010. All cars must be scrutineered and passed for competition prior to the commencement of competition on each day. CAMS Licences, Competition Records and current Club membership cards must be produced at Scrutiny, and on request during the meeting. **All vehicles competing in the 2010 Victorian Hillclimb Championship must have a CAMS Log Book**, which must be presented at Scrutiny. Entries will be accepted from competitors/vehicles without a CAMS Log Book, but these entries will only be accepted after all Log Booked entries have been accepted. Such competitors will not score points in the 2010 Victorian Hillclimb Championship.

**DRIVERS BRIEFING** The attendance of all drivers is required at a Drivers Briefing to be held at 12.40 p.m. on Saturday, February 6, 2010. Drivers who fail to attend such briefings may be liable for a penalty imposed by the Stewards. The starting order will be advised at the Drivers Briefing. Any changes to the running order during the event are at the discretion of the Clerk of Course.

**TIMING** Timing will be electronic, and be to one hundredth of a second. Event winners will be those competitors with the fastest time for a single run in each class. In the event of a tie, the next fastest official time of each competitor will determine the event winner. Timekeepers will be considered Judges of Fact.

**PROTESTS** Any protests must be lodged in accordance with Part XII of the NCR.

**ABANDONMENT** The Promoters reserve the right to abandon, postpone or cancel the meeting in accordance with NCR 59.

**SAFETY - DRIVER** Drivers must wear a helmet to a standard listed in the CAMS Manual of Motor Sport, and be deemed by the scrutineers of the event to be in a suitable condition for motorsport use, non flammable clothing, suitable footwear, and goggles or visors with lens other than glass in open cars (see Section 6, Schedule D of the CAMS Manual).

**SAFETY - CARS** The attention of competitors is drawn to Section 6 of the CAMS Manual of Motor Sport in which all vehicle requirements are listed in detail. Silencers are not mandatory, but vehicles must not exceed a noise limit of 95dB(A). Vehicles must be fitted with a fire extinguisher complying with Section 6, Schedule H of the CAMS Manual. Competitors are reminded that the possession and use of Halon/BCF fire extinguishers, other than where specific approval has been given by the E.P.A., is prohibited. Fuel must be in accordance with Schedule G of the CAMS Manual.

**ANTI-DOPING POLICY** During any competition, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the dayS of the event or practice therefore shall not be permitted to participate, Refer NCR 145A. In addition, the persons concerned will be subject to the Articles of Procedure for Alcohol Testing and CAMS Drugs in Sport Policy. Competitors, crews and officials may be tested for alcohol or other drugs at any time during the event(s). This regulation serves as the required 24 hour notice to Competitors, Crew and Officials.

**CLASSES** The competition will provide for the following classes:

- E Formula Libre 1301 to 2000cc
- F Formula Libre 2001cc and over

Classes may, at the Promoters discretion, be combined where there are less than three entries in a class. Where there are sufficient entries, further classes may be created (e.g., Formula Libre up to 500cc, etc.). Competitors in Historic – Other must provide a Certificate of Description for their vehicle.

**AWARDS** Trophies will be awarded to the person achieving fastest time of day, and to the fastest and second fastest time in each class. Further awards may be made, and these will be notified to competitors in any further information that may be forwarded to competitors and/or at the Drivers Briefing.

**TRACK CONFIGURATION** This event will be conducted on the **Clockwise Track** configuration, over a distance of approximately 1.2 kilometres.

**USE OF THE TRACK FOR PRACTICE.** The track will be available for unofficial practice on Friday, February 5, 2010 from 1.00 p.m. until 4.30 p.m., and on Saturday, February 6, 2010 from 9.00 a.m. until 12 noon.. The timing may operate (for testing purposes only) during this practice period.

**COMPETING CARS** Competing cars must be kept in the paddock area during the running of the meeting. All competitors will be allocated a numbered pit bay, and such number will be notified in the acceptance of entry. Competitors trailers must be parked in the trailer park or other designated areas, and must not be parked in spectator areas. All competitors should enter the circuit by the gate marked Competitors.

**ACCEPTANCE OF ENTRIES** Notification of the acceptance of entry will be forwarded to all competitors. The letter of acceptance will include any additional information necessary for competitors, and will also include a vehicle pass for the Spectator Car Park.
